



## **LeAnanda Yoga 200hr Teacher Training Terms and Conditions**

### **1. Introduction**

These Terms and Conditions govern the participation in LeAnanda Yoga Teacher Training (YTT) program. By registering, you agree to comply with and be bound by the following terms.

### **2. Eligibility**

- 2.1. Applicants must be at least 18 years old.
  - 2.2. A minimum level of physical fitness is required. Participants must have practised yoga regularly for at least 18 months, 2 years is preferred if you have not practiced regularly with Leanne.
  - 2.3. Participants must inform the program of any pre-existing health conditions, injuries, or limitations.
  - 2.4. Acceptance into the program is at the discretion of Leanne Jones, Course Director at LeAnanda Yoga
- 

### **3. Registration and Payment**

- 3.1. To reserve a spot, applicants must provide a reference from their existing teacher, attend the intro day and pay a non-refundable deposit of £444 GBP.
  - 3.2. Full payment is required by 30<sup>th</sup> September 2026
  - 3.3. Payment methods include bank transfer or through LeAnanda Yoga website for monthly recurring plans. No cash.

### **4. Cancellation and Refund Policy**

#### **4.1. Student Cancellations:**

- Cancellations received 14 days before the start date of the training will receive a refund minus the deposit.
- Cancellations received after this period will not be eligible for any refund.

#### **4.2. Program Cancellations:**

- LeAnanda Yoga reserves the right to cancel the program if the minimum enrolment is not met or due to unforeseen circumstances. If cancelled, participants will receive a full refund.

### **5. Attendance and Participation**

- 5.1. Participants must attend all training sessions unless an exception has been granted in advance. Missed sessions may result in additional assignments or makeup sessions.
- 5.2. Participants are expected to complete all assignments, readings, and practical assessments to the best of their ability and submit them on time.

5.3. Late arrivals, early departures, or absences without valid reasons may affect certification eligibility.

## **6. Certification Requirements**

6.1. To receive certification, participants must:

- Attend all of the training hours.
- Complete all assignments, practical assessments, and exams with satisfactory results.
- Abide by the Code of Conduct (see Section 8).

6.2. Certification is not guaranteed solely based on attendance. Certification is awarded based on meeting the training standards and requirements.

## **7. Health and Liability**

7.1. Yoga practice involves physical exertion, which may result in injury.

Participants agree to participate at their own risk and are advised to consult a healthcare provider before beginning the program.

7.2. By enrolling, participants release LeAnanda Yoga and its instructors from any liability or claim arising from participation in the training.

7.3. Participants agree to disclose any health issues that may affect their participation and are responsible for their own health and safety during the program, any health changes must be communicated with the course director immediately, including pregnancy.

## **8. Code of Conduct**

8.1. Participants are expected to behave respectfully toward teachers, facilitators, staff, and fellow students at all times.

8.2. The use of alcohol, drugs, or prohibited substances during training hours is strictly prohibited.

8.3. Inappropriate or disruptive behaviour may result in dismissal from the program without a refund.

8.4. Participants agree to uphold the integrity and ethics of yoga as taught in the program.

## **9. Intellectual Property**

9.1. All training materials, including manuals, handouts, and video/audio recordings provided during the program, are the intellectual property of LeAnanda Yoga.

9.2. Participants may use these materials for personal study but may not reproduce, distribute, or use them for teaching purposes without explicit permission.

## **10. Confidentiality and Privacy**

10.1. Personal information collected from participants will be used solely for the purpose of administering the program and communicating with participants.

10.2. LeAnanda Yoga will not share personal information with third parties unless required by law.

## **11. Amendments**

11.1. LeAnanda Yoga reserves the right to update these Terms and Conditions at any time. Participants will be notified of any changes, and continued participation implies acceptance of the amended terms.

11.2. LeAnanda Yoga reserves the right to update the content of the course or changes the days the content will be taught if that is fairly deemed appropriate for the good of the group learning outcomes and within time considerations.

12.1. Once training has commenced and your place has been offered this forms a formal contract and the participant must pay all remaining instalments even if deciding to leave the training.
